# Important Information:

Property Tax and all other expenses related to the Real Estate must be paid from the IRA account. Submit the Expense Payment Request Form and Invoice for payment. DO NOT PAY WITH PERSONAL FUNDS as this will cause a prohibited transaction in your account resulting in a taxable distribution to you which may cause additional penalties from the IRS.

**Valuation Requirement:** You are required to submit a valuation on your property at least annually. This will be used to calculate the value of your account on IRS Form 5498. You can provide this easily by logging into your account through the online secure portal.
