ADD A TRUSTED CONTACT PERSON TO YOUR ACCOUNT

To help us better protect your account and provide an additional safeguard against potential fraud, financial exploitation, or communication challenges, Forge Trust encourages you to designate a Trusted Contact Person.

WHAT IS A TRUSTED CONTACT PERSON?

A Trusted Contact Person is someone Forge Trust may contact in limited circumstances to help address concerns about your account or your well-being.

- Your Trusted Contact cannot access your account, make transactions, or change account settings.
- This person is not a power of attorney or authorized representative.
- They serve only as a point of contact if Forge Trust suspects financial exploitation or is unable to reach you.
- We recommend selecting someone you trust, such as a family member, close friend, or professional advisor.
- Your Trusted Contact must be at least 18 years old.

WHAT YOU ARE AUTHORIZING

By providing a Trusted Contact, you authorize Forge Trust Co. to contact this person and disclose limited information when necessary, including:

- Verifying your current contact information
- Discussing concerns about potential fraud or financial exploitation
- Confirming your health status or ability to manage your account
- Identifying legal representatives (e.g., guardian, executor, or power of attorney)

This authorization does not grant the Trusted Contact control or authority over your account.
